

# SDG16+ and the Pathfinders for Peaceful, Just and Inclusive Societies

at the High-level Political Forum on Sustainable Development 2019



## Pathfinders at the High-level Political Forum

At the High-level Political Forum, ten Pathfinder countries demonstrated successful implementation of SDG16+ in their **Voluntary National Reviews**. The thematic review of SDG16 was supported by a **joint statement** from 36 countries and a new version of the **Roadmap for Peaceful, Just, and Inclusive Societies**.

The Pathfinders co-hosted eight **SDG16+ events** and two **high-level dinners**, working with more than 25 government, civil society, and private sector partners.

We published major reports from the **Task Force on Justice** – as the **UN Secretary-General** called for urgent action to meet the needs of 5 billion people who are deprived of justice.

We launched the **grand challenge on inequality and exclusion**, with the announcement of an advisory council bringing together member states and key partners.

Our **SDG16+ Festival Guide** helped participants navigate the formal sessions of the HLPF and more than 110 SDG16+ side events. The **Pathfinders' Booth** informed more than 600 delegates about SDG16+.

## Key Messages on SDG16+

Our key message for the High-level Political Forum was the need for accelerated action to:

- **Significantly reduce all forms of violence everywhere**, with the aim of halving global violence.
- Shift from a world where justice is only available to the privileged few, to one that protects human rights and provides **justice for all**.
- **Transform institutions** so that they can meet the aspirations of people and underpin the ambitions of the 2030 Agenda.
- Tackle **inequality and exclusion** so that all people have a stake in a fairer and more sustainable future.

## Accelerating Action at the SDG Summit

The High-level Political Forum provides a platform for action on SDG16+ at the **SDG Summit** from 24-25 September 2019.

We hope that Heads of State and Government will use the **Leaders Dialogues** to make concrete proposals for accelerating the achievement of SDG16+ in all countries, but with targeted action to reach the furthest behind first.

We are supporting governments and partners from all sectors to register **Acceleration Actions** on SDG16+ for the summit and we are responding to the call from the **Deputy Secretary-General** for “a decade of action to deliver on the SDGs” as we mobilize for a **Decade of Action on SDG16+**.

The High-level Political Forum was held from July 9-18, 2019 under the theme “empowering people and ensuring inclusiveness and equality.” SDG16 – peaceful, just, and inclusive societies – was reviewed for the first time, alongside SDG10 (inequality). Opening the forum, the ECOSOC president called on all countries to seize an unprecedented opportunity to accelerate action on all 17 Sustainable Development Goals.

# Voluntary National Reviews from Pathfinder Countries



## Central African Republic

CAR is implementing its Recovery and Peacebuilding Plan (2017-2021). It announced plans to set up a governance group working on SDG16, and has accelerated progress towards post-conflict recovery through its peace and reconciliation agreement between armed groups in February 2019. Challenges: high rates of crime and sexual violence, endemic corruption, income inequality, and women's political participation.



## Ghana

Enacted legislation to prevent all forms of domestic violence and abuse and ensure access to justice for all. Pre-trial detention has been cut from 30 percent in 2007 to 13 percent in 2018 and birth registration has increased from 63 percent in 2011 to over 71 percent in 2017. Challenges remain: Ghana reports that psychological and sexual violence remain higher than expected among women.



## Guatemala

Though there has been progress in reducing crime, citizens' trust in security institutions remains low. Challenges and priorities ahead: strengthening institutions and access to justice, and reducing inequalities, especially for indigenous populations, women and people with disabilities.



## Indonesia

Increased financial inclusion (especially for the poorest), strengthened democracy, reduced corruption, expanded birth registration, and greater access to legal aid. Challenges include: limited access to responsive public services, unequal quality education and economic opportunity, and inadequate data and information.



## Liechtenstein

Progress towards greater social cohesion, legal certainty, and ability to combat corruption and money laundering. Challenges: accessibility and usability of digital platforms for all social groups; ending discriminatory comments against social groups in media fora; and strengthening efforts to support migrant integration and citizen relations.



## Rwanda

Governance reforms to consolidate peace, build strong and accountable public institutions, and create a stable environment conducive to investment and growth, spurring inclusive growth (lifting millions out of poverty), fighting corruption, and expanding access to quality justice.



## Sierra Leone

Strong reporting on increasing access to justice (more than 215,000 people have benefited from legal representation, advice, and education), anti-corruption, and birth registration. Created Government Commissions to coordinate service delivery on human rights and inclusion.



## Timor-Leste

Created independent human rights, anti-corruption, and electoral institutions; promoted decentralization; built institutional capacity; and strengthened the justice sector. Challenges include: low birth registration rates, a dearth of well-trained lawyers, weak institutional capacity, and high rates of domestic violence and violence in schools.



## Tunisia

Gender equality policy was reinforced during the 2018 municipal elections, with 48% of the candidates being women and 20% of mayors elected were women. National social protection programs for the poor have risen from 22% in 2010 to 50% in 2019. Challenges: economic growth and unemployment rates remain stagnant.



## United Kingdom

Progress on protection for the rights of minorities and vulnerable people, strengthening the criminal justice system (crime has fallen by 40 percent over the last decade), tackling fraud and corruption, and increasing transparency in public services. £5 million invested in an innovation fund to support access to justice.



## Roadmap for Peaceful, Just and Inclusive Societies

The Roadmap provides a shared vision for how to deliver the 2030 Agenda targets for peaceful, just and inclusive societies (SDG16+). This updated version includes 4 new Pathfinders (Ethiopia, Germany, Jordan, and Norway) and a new foreword signed by all 31 member states.




## Justice for All: Final Report

From the Pathfinders' Task Force on Justice chaired by Ministers of Argentina, the Netherlands, and Sierra Leone, and the Elders. Drawing on research by the world's leading justice organizations and experts, the report provides a first estimate of the global justice gap, and makes the case for shifting from a model that provides justice for the few, to one that delivers measurable improvements in justice for all.



## Justice for All: Highlights and Policy Recommendations

Summarizes the main message of the Task Force: "To deliver justice for all by 2030 in a world where billions of people are not yet able to obtain justice, we must resolve justice problems, prevent injustices from occurring, and use justice systems to create opportunities for people to participate fully in their societies and economies."



## Grand Challenge on Inequality and Exclusion Challenge Paper

Highlights the exciting ideas and practices which are emerging or already taking place in the area of inequality and inclusion and presents policy options that are practical in technical terms, viable in political terms, and can be applied on a cross-regional basis.
