### The next big leap for closing the global justice gap isn't only about what we do, it also is about who we reach and how we talk about it

#### **Overview**

We know that when people can resolve their justice problems, they are less likely to be trapped in poverty, more likely to finish school, healthier, safer, and better equipped to face the future, including by building climate resilience and accessing economic opportunities. But here's the challenge: those outside the justice community don't always see these connections. They don't usually think about "justice", even when it's at the heart of their goals. That's where this event comes in.

To close the global justice gap, the justice and rule of law sector has built an international movement based on the <u>principles of people-centered justice</u>, which was catalyzed in 2021 by the creation of the <u>Justice Action Coalition</u>—a group comprising countries and partners who are leading the international effort to secure meaningful access to justice for all.

This event aims to explore new tools to improve people-centered justice communications strategies, taking the movement beyond the "justice" world and into new spaces through effective advocacy and messaging. This event will include a panel of advocacy and communications experts who offer fresh perspectives and unconventional thinking. By design, the panelists come from outside the justice sector, offering authentic insights into how justice can resonate with diverse audiences. These experts will share their approaches to advocacy, messaging, audience engagement, and campaigning, and offer practical advice about how the justice community can break out of its communication "bubble". The discussion will explore ways to connect meaningfully with wider audiences – from policy experts, diplomats, and business leaders, to communities far removed from the policy arena altogether.

#### **Background: The People Centered Justice Movement**

Within the justice sector, there is a growing consensus that the most effective way to close the justice gap and ensure equal access to justice for all is by embracing people-centered justice—"a systemic approach to prevent and resolve people's justice problems." This approach is premised on the following ideas:

- Understanding people's justice needs, their experiences in seeking justice, and the justice they receive.
- Prioritizing data collection to design and support evidence-based policies and systems, which deliver fair outcomes for people.
- Ensuring that people are empowered to understand, use, and shape laws and policies, enabling them to claim their rights, seek justice, and resume their daily lives.

• Seeking to transform institutions, simplify processes, and make services accessible by breaking down barriers to justice, which has both social and economic benefits.

Over the past few years, the Justice Action Coalition members have successfully established a shared vision and movement for people-centered justice within the sector. Advocacy efforts are reflected in the <a href="Messages on People-Centered Justice">Key Messages on People-Centered Justice</a>, a series of global <a href="Actions We Must Take to Achieve People-Centered Justice">Achieve People-Centered Justice</a>, and a <a href="Thematic Repository of Messages on People-Centered Justice">The messages</a> within these tools reflect the sector's ambition and potential.

With established collective action around people-centered approaches within the justice sector, justice advocates are now turning to the next frontier: showing leaders, policymakers, and practitioners, including those outside the justice sector, why access to justice is fundamental to achieving their goals.
