Making Justice Count: Exploring the Role of People-Centered Justice Research and Data for Effective, Inclusive, and Accountable Governance

This is a side event of the Open Government Partnership (OGP) Global Summit. It is hosted by the American Bar Foundation, Hague Institute for Innovation of Law (HiiL), Pathfinders for Peaceful, Just, and Inclusive Societies, and the Organisation for Economic Co-operation and Development (OECD).

- **Audience:** Government and civil society OGP members at both the national and local level, multilateral partners, and governance practitioners.
- **Outcomes:** Attendees will leave with a strong shared understanding of what "people-centered justice data" means in practice and how it can be useful to improve accountability and inclusion. They will also have increased awareness of the role of data in open justice and accountable institutions.

Overview

This session will explore how research and data can be used to advance people-centered justice approaches—those which reorient justice systems to people’s lived experiences and needs. People-centered justice supports government accountability and inclusive access to rights and services. It can ensure governance is effective and efficient. Understanding people’s justice needs through research and data collection helps governments and civil society organizations to develop solutions that work to resolve them and innovative new ways to address the challenges of building inclusive societies.

This discussion will bring together experts working at different levels to explore how evidence for people-centered justice can be generated, shared, and used to shape policies that respond to people’s needs, build sustained justice data systems, and support transparent, accountable, and inclusive societies.

The session will highlight three distinct but complementary perspectives:

- **OECD | Justice Action Coalition Workstream on Data & Evidence:**
The [Justice Action Coalition](#) is a multi-stakeholder alliance of countries and organizations that is working to achieve measurable progress in justice outcomes for people and communities. The session will include an overview of the [Justice Action Coalition](#)’s global efforts to strengthen justice data systems. The OECD will share key takeaways on data gaps, standards, and opportunities for improving evidence-based policymaking as well as findings from their work to make the economic case for people-centered justice.
- **American Bar Foundation (ABF) | Justice Data Observatory:**
The [Justice Data Observatory \(JDO\)](#) aims to understand, shape, and build global evidence that informs how people-centered access to justice can combat poverty and inequality, promote inclusive development and growth, and empower democratic participation and governance through sustained research to support evidence-based policy and practice. The ABF will reflect on JDO’s global research, including a two-year study investigating global trends in people-centered justice research and evidence through insights from academic, civil society, and government experts in more than 20 countries.
- **HiiL and African Alliance for People-Centered Justice (AAPCJ) | Policy Brief on People-Centered Justice Data:**
The [African Alliance for People-Centered Justice](#) is an innovative initiative aimed at promoting people-centered approaches to addressing the justice needs of Africa’s diverse and fast-growing population. Speakers from (AAPCJ) will provide a regional perspective from the African continent, focusing on the development of a policy brief that centers people’s experiences in justice systems. The African Alliance will share early findings, advocacy aims, and how data is being used to drive more inclusive justice outcomes with links to effective governance.

The session will be moderated by **Pathfinders** who acts as part of the Secretariat for the Justice Action Coalition and launched the African Alliance for People-Centered Justice in 2024.

Objectives:

- Showcase innovative work to generate, analyze, and apply people-centered justice data to create more just, inclusive, and equal societies.
- Share lessons across global, regional, and research-based perspectives.
- Explore barriers to meaningful justice data collection and use for both governments and civil society partners
- Identify opportunities for collaboration, standardization, and scaling between justice and other development sectors. Inspire OGP stakeholders to prioritize justice data as part of their open government commitments.
