Introduction

Drawing on inspiration from the successful 2024 United Nations (UN) Asia-Pacific Regional Conference on People-Centered Justice, co-convened by the International Development Law Organization (IDLO) with the UN Development Programme (UNDP), the UN Environment Programme (UNEP), UN Women, the World Justice Project, and others, and building on the momentum of the African Alliance on People-Centered Justice (AAPCJ) since its launch in November 2024, the African Regional Forum on People-Centered Justice will convene diverse stakeholders to chart a path forward for people-centered justice in Africa. The Forum will be held alongside the 85th Ordinary Session of the African Commission on Peoples and Human Rights (ACPHR) in Banjul, The Gambia, to leverage the presence of a broad spectrum of key stakeholders. This session will explore how the African Union (AU) and regional bodies like the ACHPR and the Economic Community of West African States (ECOWAS) can be instrumental in expanding access to justice across the continent. It will focus on how to align various like-minded interests to ensure equitable delivery of justice in Africa. The session will also highlight existing opportunities at a regional level for leveraging resources and partnerships to promote people-centered justice at the national level.

Background and Rationale

The African continent faces persistent challenges in ensuring equitable and accessible justice for all its citizens. Despite the existence of regional human rights mechanisms, such as the ACHPR, many countries struggle to effectively leverage these mechanisms to address domestic legal and human rights issues, including access to justice issues. National governments, regional bodies, and international partners must work collaboratively to strengthen the influence of these institutions, promote human rights, and improve access to justice, including reparative justice.

This session is designed to explore practical strategies for African nations to actively shape and benefit from regional human rights bodies, ensuring that they serve as catalysts for meaningful reform. They also aim to identify opportunities within regional leadership, such as the ECOWAS presidency, to elevate people-centered justice across the region, responding to the emerging need for inclusive, responsive, and sustainable justice systems. Furthermore, this session will highlight past successes in promoting legal reforms, access to justice, and human rights awareness through the ACHPR, while drawing attention to new and emerging challenges, such as the theme of justice for Africans and people of African descent through reparations. The session will investigate how a people-centered justice approach to reparations focuses on addressing the needs, voices, and experiences of impacted communities.

The focus on strengthening access to justice through the ACHPR's guidance and influence responds to the demand for practical tools and normative frameworks that can be adapted and implemented at the national level. Similarly, aligning donor programming with regional justice needs highlights the importance of coordinated efforts that prioritize localized solutions and sustainable development. Together, the session topics aim to foster a more responsive, participatory, and resilient regional justice landscape capable of confronting present and future challenges.

Session Objectives

- Explore mechanisms for effectively integrating ACHPR recommendations and frameworks into national laws and policies.
- Examine opportunities within Sierra Leone's ECOWAS presidency to prioritize and advance people-centered justice initiatives.
- Analyze how ACHPR's normative documents and decisions can be adapted to improve access to justice at the national level.
- Examine how donor initiatives can be strategically aligned with regional justice priorities to maximize the impact of people-centered justice programs.
