

Justice Action Coalition (JAC) Communications Working Group 2025 Strategy and Workplan

March 2025

Core Functions of the JAC Communications Working Group

In 2024, the JAC Communications Working Group (JAC Comms WG) was established with the following functions:

- 1. Continue to refine and update a shared vision on people-centered justice and what it means in practice in coordination with the other workstreams of the Justice Action Coalition.
- 2. Identify key opportunities at the global level to promote and profile people-centered justice
- 3. Design effective communication and advocacy strategies on people-centered justice, linking it to the sustainable development goals.

In pursuit of the third function of the JAC Comms WG, and with recognition of the ongoing needs to fulfill functions 1 and 2, it is an opportune moment for the group to establish long-term and short-term goals that can inform the group's 2025 strategy.

Long-term Goals for the JAC Communications Working Group

Based upon these functions, it is important for the WG to have long-term goals that can guide year-to-year activities:

- Establish people-centered justice as common nomenclature among governments, multilateral institutions, civil society, and academia in the justice space and broader development sector, as well as among everyday citizens discussing justice.
- Using an all-of-government approach, ensure policymakers, practitioners, and experts at the
 international and national level have a clear understanding of the principles of people-centered
 justice and how they apply in practice, with due consideration for varying geographic,
 institutional, and demographic contexts.
- Increase the number of countries promoting people-centered justice approaches in their statements, policies, strategies, and programming.
- Demonstrate the centrality of access to justice for all to the achievement of the Sustainable Development Goals, the improvement of livelihoods, and the upholding of human rights.
- Recurrently disseminate the outputs from JAC workstreams on data and evidence, catalytic
 funding for national initiatives, and a justice financing framework in a compelling and engaging
 manner, linking key messages to these outputs.

2025 Goals

In 2025, the achievement of the following goals can help to support the achievement of long-term goals.

- Socialize the Key Messages and Actions for People-Centered Justice document among JAC country and CSO members and encourage the collective use of these messages in communications, statements, and declarations during key moments of 2025.
- Establish interactive platforms and processes to promote shared communication on peoplecentered justice among JAC Comms WG members.
- Create a targeted and cohesive communications campaign across JAC Comms WG using the eight
 (8) actions of the Key Messages and Actions for People-Centered Justice and the inputs from JAC
 workstreams 1, 2, and 4.

Four Key Moments

- 1. June 23-26. World Justice Forum (Warsaw) + JAC Senior Level Meeting
- 2. June 30-July 3. 4th International Conference on Financing for Development (Sevilla)
- 3. **September 9-23.** UN General Assembly High-Level Week (New York) + UN Sixth Committee Meetings on Rule of Law and Access to Justice
- 4. **November 12-14.** OECD Global Roundtable on Equal Access to Justice (Madrid) + JAC Ministerial Meeting

It is also important for this communication strategy to be localized within national and regional contexts. Those using this communications strategy can identify key moments and adapt the tools provided here for relevant use.

Planned Activities

The following is a running list of activities the group can enact to achieve the 2025 goals:

A) Create <u>Communications toolkits</u> based on "Key Messages and Actions for People-Centered Justice" for 5 key moments. Each communications toolkit will be presented as a 2-pager that includes draft social media posts, social cards, relevant hashtags, and relevant reports to promote.
